## **CIRCULAR**

Respected Member,

In view of the requests of the members, last date for giving entries for 2<sup>nd</sup> AMARENDRA SHARAN MEMORIAL BADMINTON TOURNAMENT organised by the Supreme Court Bar Association is extended till today, i.e., 15.09.2022.

Interested Members may give their name in SCBA office alongwith requisite fees. Entries are being called for **Singles, Doubles** and **Mixed Doubles** in the age group of **22-35, 36-50, 50-60 and 60+**. However, members falling in different age groups can play together as a team in doubles and mixed doubles category, but in the younger age group only.

All matches would be played in "DDA Squash and Badminton Stadium" adjacent to Gargi College, August Kranti Marg, New Delhi. Entry of spectators in DDA stadium would be as per the prevalent Covid protocol.

Entry fees for **singles** would be **Rs.500/-** and for **doubles/mix doubles Rs.1000/- per team**. While making payment, members are requested to give the size of their T-Shirt and Track Pant in the SCBA Office.

The tournament would be played in a knockout format with Yonex 350 or equivalent plastic shuttle. Members have to be compulsorily in sportswear for the matches, have to bring their own racket and have to wear "Non marking shoes".

Members are informed that all round robin matches would be of single game of 21 points whereas Semi Final and Final would be best of three games of 21 points each.

Reporting time is half an hour before the match. If a member/team does not reach in time, other member/team will get a walkover.
